Schedule: Practice from 9:15am to 10:00, check-in by 9:30. Matches start at 10:00. Tournament ends at 6pm.

Tournament format: Giant-Round Robin, 11 Point games, 3 of 5. Play will be in three stages. Preliminary stage: Will consist of 10 round robin groups of 5 players. Everyone advances to next stage. Stage 2: Based on playing records in preliminary groups, players will be placed into Division A, B, C, D or E. Each Division will have 2 groups of round robin play. Stage 3 is single elimination of group winners and runner-ups. *Unrated players will be rated by tournament committee*. Limit pre-match warmups to 2 minutes. **USATT membership is required for this event.** See membership information below.

Awards: Division A: 1st \$200 and trophy; 2nd \$100 and trophy
All other Divisions: 1st Trophy; 2nd Trophy

Entry Deadline: Entries must be received by 5pm Friday February 26rd. First 50 Paid entries will be accepted.

Tournament Committee: Judd Disch, Chris Salazar and Bob Leatherwood. Richard McAfee is referee.

Equipment: Butterfly 3 star orange 40mm balls will be used. All matches will be played on a rubberized wood floor using an assortment of tables and nets, all USATT approved.

Rules: All USATT regulations apply, including dress code (absolutely no orange/red shirts or large decals allowed). Tournament Committee reserves the right to modify format and prizes to accommodate the number of entries or cancel event and refund money in case of insufficient entries. Players may receive a full refund if notified at least one day before the event day. **Minors must be accompanied by an adult.**

Membership: Proof of USATT membership is required. Membership may be purchased on the day of the event. Adult membership \$40/year or \$105/3 years. Junior and college student is \$20/year. Players who do not want to purchase a full membership may purchase a tournament pass at a cost of \$10.
